Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures and budget transfers for the Education, Health & Human Services, and Legislative Departments for the Fiscal Year ending September 30, 2017.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures and budget transfers for the Education, Health & Human Services, and Legislative Departments for the Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: One thousand seventy-three dollars and no cents (\$1,073.00) for Community Services Block Grant 201-330 of FY17 Grant Funds as submitted under **Education**; Three thousand forty-five dollars and no cents (\$3,045.00) for FDPIR Commodities 220-452 of FY17 Grant Funds as submitted under **Health & Human Services**; Five thousand nine hundred ninety dollars and no cents (\$5,990.00) for Gagiiginindizodaa Ojibwe Language Program 100-NEW of FY17 Oyate Network Alumni Grant Funds to act as the fiscal agent for the Gagiiginindizodaa Ojibwe Language Program as submitted under **Legislative** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred thirty million four hundred twenty-seven thousand one hundred fifty-eight dollars and twelve cents (\$230,427,158.12).

For revisions <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget revisions within programs of <u>up</u> to 50% of the total program's budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
