### Ordinance 10-17

An Ordinance of Supplemental Appropriation for Adult Band Member Supplemental Economic Payments from the Ramah Settlement Fund and Tax Revenue Fund for Fiscal Year ending September 30, 2017.

The District II Representative introduced the following Bill on the 17<sup>th</sup> day of November, 2016.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Ramah Settlement Fund and Tax Revenue Fund for Fiscal Year ending September 30, 2017.

### Title I

Section 1: Ramah Settlement Funds and Tax Revenue Funds: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments, from Ramah Settlement Fund and Tax Revenue Fund for Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of : One million nine hundred one thousand eight hundred ninety-eight dollars and forty-five cents (\$1,901,898.45) of FY17 Ramah Settlement Funds; One million three hundred seven thousand one hundred one dollars and fifty-five cents (\$1,307,101.55) of FY17 Tax Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective December 1, 2016) for Supplemental Economic Payments which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: One hundred fifty-nine million five hundred eighty-seven thousand three hundred ten dollars and forty-two cents (\$159,587,310.42); and
