

Ordinance 04-17

An Ordinance of Supplemental Appropriation and Budget Revision for the Legislative and Justice Departments for the Fiscal Years ending September 30, 2016 and September 30, 2017.

The District III Representative introduced the following Bill on the 20<sup>th</sup> day of October, 2016.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of authorizing a Supplemental Appropriation and Budget Revision for the Legislative and Justice Departments for the Fiscal Years ending September 30, 2016 and September 30, 2017.

Title I

Section 1: Governmental Operations. The Band Assembly hereby authorizes a Supplemental Appropriation and Budget Revision for the Legislative and Justice Departments for the Fiscal Years ending September 30, 2016 and September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: One hundred thousand dollars and no cents (\$100,000.00) for Solicitor General 100-215 of FY16 Unspent/Net Revenue to cover increased legal expenses under **Department of Justice** which amends the **Total Fiscal Year 2016 Mille Lacs Band Tribal Operations** to read: Three hundred fifty-three million five hundred nineteen thousand three hundred seventy-two dollars and seventy-two cents (\$353,519,372.72).

Thirty-three thousand six hundred fifty-four dollars and ninety-seven cents (\$33,654.97) for District III 100-103 of FY16 Carryover of Unspent/Net Revenue Funds to continue to support the DIII historic project under **Legislative** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: One hundred twenty-two thousand five hundred ninety-nine thousand eighty-two dollars and eighty cents (\$122,599,082.80).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:


