

Ordinance 28-17

An Ordinance of Supplemental Appropriation for The Chief Executive Department for Fiscal Year ending September 30, 2017.

The District II Representative introduced the following Bill on the 6th day of April, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for The Chief Executive Department for the fiscal year ending September 30, 2017.

Title I.

Section 1: Unspent/Net Revenue. The Band Assembly hereby appropriates and authorizes an expenditure for The Chief Executive Department for fiscal year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: Five hundred twenty-five thousand dollars and no cents (\$525,000.00) for Chief Executive 100-200-5700 of FY17 Unspent/Net Revenue Funds to purchase two turf level stadium suites at the Minnesota Vikings Football Stadium for the 2017 season under **Chief Executive** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred twenty-one million fifty-two thousand four hundred four dollars and twenty-five cents (\$221,052,404.25).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:



Band Assembly Bill 17-03-28-17

A Bill of Supplemental Appropriation for The Chief Executive Department for Fiscal Year ending September 30, 2017.

Preamble

Title I.

Section 1: Unspent/Net Revenue. The Band Assembly hereby appropriates and authorizes an expenditure for The Chief Executive Department for fiscal year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: Five hundred twenty-five thousand dollars and no cents (\$525,000.00) for Chief Executive 100-200-5700 of FY17 Unspent/Net Revenue Funds to purchase two turf level stadium suites at the Minnesota Vikings Football Stadium for the 2017 season under **Chief Executive** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred twenty-one million fifty-two thousand four hundred four dollars and twenty-five cents (\$221,052,404.25).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
