### Ordinance 20-17

An Ordinance of Supplemental Appropriation for the Natural Resources, and Health & Human Services Departments for the Fiscal Year ending September 30, 2017.

The District I Representative introduced the following Bill on the 28th day of February, 2017.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Natural Resources, and Health & Human Services Departments for the Fiscal Year ending September 30, 2017.

### Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Natural Resources, and Health & Human Services Departments for the Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five thousand dollars and no cents (\$5,000.00) for DNR General 250-530 of FY17 GLIFWC Grant Funds as submitted; Four hundred two thousand dollars and no cents (\$402,000.00) for Real Estate 250-595 of FY17 Permanent Initiative Funds for the acquisition of 2.55 acres of lakeshore property in Wahkon as submitted; Six hundred fifteen thousand dollars and no cents (\$615,000.00) for Real Estate 250-595 of FY17 Permanent Initiative Funds for the acquisition of 14.35 acres of lakeshore property on Big Sandy Lake in D2 as submitted; Twenty-three thousand two hundred fifty-one dollars and no cents (\$23,251.00) for Fire Prep 250-549 of FY17 Self Governance Funds as submitted under Natural Resources; Six hundred thousand dollars and no cents (\$600,000.00) for 4 Winds 220-NEW of FY17 State Grant Funds to support the facility acquisition and operation as submitted under Health & Human Services which amends the Total Fiscal Year 2017 Mille Lacs Band Tribal Operations to read: Two hundred four million two hundred thirty-four thousand two hundred seventy-four dollars and fifty-eight cents (\$204,234,274.58).
