

Ordinance 41-17

An Ordinance of Supplemental Appropriation for August 2017 and September 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

The District III Representative introduced the following Bill on the 18th day of July, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for August 2017 and September 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for August 2017 and September 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six million two hundred twenty-five thousand nine hundred nine dollars and no cents (\$6,225,909.00) of FY17 Bonus Distribution Funds for Adult Distributions 100-198-6668; Four million three hundred forty thousand dollars and no cents (\$4,340,000.00) of FY17 Bonus Distribution Funds for Minor Distributions 100-198-6668; Five thousand dollars and no cents (\$5,000.00) of FY17 Bonus Distribution Funds for Admin costs 100-198-4550 under **Bonus Distribution** which also amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred forty-one million four hundred sixteen thousand one hundred twenty-four dollars and twelve cents (\$241,416,124.12).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:


