

Ordinance 14-17

An Ordinance of Supplemental Appropriation for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

The District III Representative introduced the following Bill on the 3rd day of January, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes an expenditure for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six million seven hundred fifty-six thousand three hundred fifty-two dollars and no cents (\$6,756,352.00) for Clinic Building 330-000 of FY17 Unspent/Net Revenue Funds for updated commercial construction costs of the D1 Health & Human Services building as submitted under **Health & Human Services** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: One hundred sixty-eight million eighty-nine thousand fifty-seven dollars and forty-two cents (\$168,089,057.42).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:

A Bill of Supplemental Appropriation for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes an expenditure for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six million seven hundred fifty-six thousand three hundred fifty-two dollars and no cents (\$6,756,352.00) for Clinic Building 330-000 of FY17 Unspent/Net Revenue Funds for updated commercial construction costs of the D1 Health & Human Services building as submitted under **Health & Human Services** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: One hundred sixty-eight million eighty-nine thousand fifty-seven dollars and forty-two cents (\$168,089,057.42).
