

Ordinance 17-17

An Ordinance of Supplemental Appropriation for February 2017 and March 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

The District III Representative introduced the following Bill on the 2nd day of February, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for February 2017 and March 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for February 2017 and March 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million six hundred forty-six thousand five hundred sixteen dollars and no cents (\$5,646,516.00) of FY17 Bonus Distribution Funds for Adult Distributions 100-198-6668; Five thousand dollars and no cents (\$5,000.00) of FY17 Bonus Distribution Funds for Admin costs 100-198-4550 (February 2017 and March 2017) under **Bonus Distribution** which also amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred one million three hundred twenty-six thousand six hundred fifty dollars and ninety-six cents (\$201,326,650.96) and
