

Ordinance 42-17

An Ordinance of Supplemental Appropriation for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

The District I Representative introduced the following Bill on the 25<sup>th</sup> day of July, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Fifty thousand dollars and no cents (\$50,000.00) for Re-Entry 220-453 of FY17 Grant Funds as submitted; One hundred eighty thousand six hundred forty-three dollars and no cents (\$180,643.00) for Women's Halfway House 220-438 of FY17 Grant Funds as submitted under **Health & Human Services** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred forty-one million six hundred forty-six thousand seven hundred sixty-seven dollars and twelve cents (\$241,646,767.12).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:

In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

All funds appropriated are maximum fund amounts and shall not be exceeded.

A Bill of Supplemental Appropriation for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Health & Human Services Department for the Fiscal Year ending September 30, 2017.
