

Ordinance 09-17

An Ordinance of Supplemental Appropriation for December 2016 and January 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

The District I Representative introduced the following Bill on the 17th day of November, 2016.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for December 2016 and January 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for December 2016 and January 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million eight hundred twenty-four thousand eight hundred thirty-one dollars and no cents (\$5,824,831.00) of FY17 Bonus Distribution Funds for Adult Distributions 100-198-6668; Four million twenty-one thousand two hundred fifty-three dollars and no cents (\$4,021,253.00) of FY17 Bonus Distribution Funds for Minors Distributions 100-198-6668; Five thousand dollars and no cents (\$5,000.00) of FY17 Bonus Distribution Funds for Admin costs 100-198-4550 (December 2016 and January 2017) under **Bonus Distribution**; Three hundred ninety-three thousand six hundred fourteen dollars and no cents (\$393,614.00) of FY17 Taxation Revenue Funds for Adult Distributions 100-198-6668; One hundred thirty-nine thousand five hundred forty-seven dollars and no cents (\$139,547.00) of FY17 Taxation Revenue Funds for Minors Distributions 100-198-6668 under **Taxation Revenue** which also amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: One hundred fifty-six million three hundred seventy-eight thousand three hundred ten dollars and forty-two cents (\$156,378,310.42) and


