

Ordinance 25-17

An Ordinance of Supplemental Appropriation for the Legislative Department for the Fiscal Year ending September 30, 2017.

The District II Representative introduced the following Bill on the 21st day of March, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing an expenditure for the Legislative Department for the Fiscal Year ending September 30, 2017.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes an expenditure for the Legislative Department for the Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes an expenditure of: Three hundred forty-six thousand dollars and no cents (\$346,000.00) as the remaining and final portion of the 2016-2017 Band donation from the Mille Lacs Band to the Minisinaakwaang Leadership Academy 201-306 of FY17 Unspent/Net Revenue Funds to provide Ojibwe Culture & Language activities, academic infrastructure, and technology services to its students under **Legislative** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred seventeen million four hundred ninety-one thousand two hundred fifty-eight dollars and twenty-five cents (\$217,491,258.25).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

A Bill of Supplemental Appropriation for the Legislative Department for the Fiscal Year ending September 30, 2017.

The District II Representative introduced the following Bill on the 21st day of March, 2017.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing an expenditure for the Legislative Department for the Fiscal Year ending September 30, 2017.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes an expenditure for the Legislative Department for the Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes an expenditure of: Three hundred forty-six thousand dollars and no cents (\$346,000.00) as the remaining and final portion of the 2016-2017 Band donation from the Mille Lacs Band to the Minisinaakwaang Leadership Academy 201-306 of FY17 Unspent/Net Revenue Funds to provide Ojibwe Culture & Language activities, academic infrastructure, and technology services to its students under **Legislative** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred seventeen million four hundred ninety-one thousand two hundred fifty-eight dollars and twenty-five cents (\$217,491,258.25).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Pursuant to the powers listed in 3 MLBSA § 16(c) "...each bill shall be personally delivered to the Chief Executive, who shall have five calendar days from the date of receipt to either sign the bill into law, or veto the bill...In the event he neither signs the bill or vetoes it, it shall become law without his signature after the expiration of five days from the date of receipt of the bill."

Band Assembly Bill 17-03-25-17 was delivered to the Chief Executive Office on March 22, 2017 at 10:30 a.m. and on March 29, 2017 at 8:32 a.m. it was returned to the Legislative office without the Chief Executives signature nor a written veto message containing objections to the Bill. At this time, the Bill becomes law and will be forwarded to The Office of Management and Budget to be processed.




