An Ordinance of Budget Transfers for the Education Department for the Fiscal Year ending September 30, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of authorizing budget transfers for the Education Department for the Fiscal Year ending September 30, 2017.

Title I

FY2017 Education: Budget transfers to cover deficit amounts as submitted (see attachment):




