

Ordinance 52-17

An Ordinance of Supplemental Appropriation for October 2017 and November 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

The District II Representative introduced the following Bill on the 19<sup>th</sup> day of September, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for October 2017 and November 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for October 2017 and November 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million four hundred ninety-three thousand five hundred four dollars and no cents (\$5,493,504.00) of FY18 Bonus Distribution Funds for Adult Distributions 6668-100-1980-0; Five thousand dollars and no cents (\$5,000.00) of FY18 Bonus Distribution Funds for Admin costs 4550-100-1980-0 under **Bonus Distribution** which also amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Five million four hundred ninety-eight thousand five hundred four dollars and no cents (\$5,498,504.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:





Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for October 2017 and November 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million four hundred ninety-three thousand five hundred four dollars and no cents (\$5,493,504.00) of FY18 Bonus Distribution Funds for Adult Distributions 6668-100-1980-0; Five thousand dollars and no cents (\$5,000.00) of FY18 Bonus Distribution Funds for Admin costs 4550-100-1980-0 under **Bonus Distribution** which also amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Five million four hundred ninety-eight thousand five hundred four dollars and no cents (\$5,498,504.00).
