

Ordinance 46-17

An Ordinance of Supplemental Appropriation for Adult Band Member Supplemental Economic Payments from the Non-Gaming Revenue Fund for Fiscal Year ending September 30, 2017.

The District II Representative introduced the following Bill on the 8th day of August, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Non-Gaming Revenue Fund for Fiscal Year ending September 30, 2017.

Title I

Section 1: Non-Gaming Revenue: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments from the Non-Gaming Revenue Fund for Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of : Three million two hundred forty-six thousand dollars and no cents (\$3,246,000.00) of FY17 Non-Gaming Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective August 17, 2017) for Supplemental Economic Payments which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred fifty million nine hundred sixty-one thousand three hundred ninety-two dollars and twelve cents (\$250,961,392.12); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

A Bill of Supplemental Appropriation for Adult Band Member Supplemental Economic Payments from the Non-Gaming Revenue Fund for Fiscal Year ending September 30, 2017.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Non-Gaming Revenue Fund for Fiscal Year ending September 30, 2017.

Title I

Section 1: Non-Gaming Revenue: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments from the Non-Gaming Revenue Fund for Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of : Three million two hundred forty-six thousand dollars and no cents (\$3,246,000.00) of FY17 Non-Gaming Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective August 17, 2017) for Supplemental Economic Payments which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred fifty million nine hundred sixty-one thousand three hundred ninety-two dollars and twelve cents (\$250,961,392.12); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
