

Ordinance 22-17

An Ordinance of Supplemental Appropriation for the Judicial Department for the Fiscal Year ending September 30, 2017.

The District II Representative introduced the following Bill on the 9<sup>th</sup> day of March, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing an expenditure for the Judicial Department for the Fiscal Year ending September 30, 2017.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes an expenditure for the Judicial Department for the Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: Twenty-four thousand two hundred sixty-nine dollars and no cents (\$24,269.00) for Tribal Court 100-150 of FY17 Unspent/Net Revenue Funds for the purchase of equipment and installation costs for the Bailiff's vehicle that will also allow him to be equipped to handle duties on the road as a licensed Police Officer under **Judicial** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred six million seven hundred sixty-nine thousand three hundred twelve dollars and twenty-five cents (\$206,769,312.25).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:

A Bill of Supplemental Appropriation for the Judicial Department for the Fiscal Year ending September 30, 2017.

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing an expenditure for the Judicial Department for the Fiscal Year ending September 30, 2017.

Title I
