#### Ordinance 12-17

An Ordinance of Supplemental Appropriation and Budget Transfers/Revisions for the Administration, Education, and Health & Human Services Departments for the Fiscal Year ending September 30, 2016.

The District I Representative introduced the following Bill on the 29th day of November, 2016.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures and Budget Transfers/Revisions for the Administration, Education, and Health & Human Services Departments for the Fiscal Year ending September 30, 2016.

### Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures and Budget Transfers/Revisions for the Administration, Education, and Health & Human Services Departments for the Fiscal Year ending September 30, 2016.

All funds appropriated are maximum fund amounts and shall not be exceeded.
