

Ordinance 24-17

An Ordinance of Supplemental Appropriation for April 2017 and May 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

The District I Representative introduced the following Bill on the 21st day of March, 2017.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for April 2017 and May 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for April 2017 and May 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million nine hundred two thousand one hundred fifty-eight dollars and no cents (\$5,902,158.00) of FY17 Bonus Distribution Funds for Adult Distributions 100-198-6668; Four million three hundred twenty-eight thousand eight hundred dollars and no cents (\$4,328,800.00) of FY17 Bonus Distribution Funds for Minor Distributions 100-198-6668; Five thousand dollars and no cents (\$5,000.00) of FY17 Bonus Distribution Funds for Admin costs 100-198-4550 under **Bonus Distribution** which also amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred seventeen million one hundred forty-five thousand two hundred fifty-eight dollars and twenty-five cents (\$217,145,258.25).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:



Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for April 2017 and May 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for April 2017 and May 2017 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million nine hundred two thousand one hundred fifty-eight dollars and no cents (\$5,902,158.00) of FY17 Bonus Distribution Funds for Adult Distributions 100-198-6668; Four million three hundred twenty-eight thousand eight hundred dollars and no cents (\$4,328,800.00) of FY17 Bonus Distribution Funds for Minor Distributions 100-198-6668; Five thousand dollars and no cents (\$5,000.00) of FY17 Bonus Distribution Funds for Admin costs 100-198-4550 under **Bonus Distribution** which also amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Two hundred seventeen million one hundred forty-five thousand two hundred fifty-eight dollars and twenty-five cents (\$217,145,258.25).
