Ordinance 14-18

An Ordinance of Supplemental Appropriation for February and March 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for February and March 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for February and March 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million seven hundred thirteen thousand six hundred ninety-two dollars and no cents (\$5,713,692.00) of FY18 Bonus Distribution Funds for Adult Distributions 6668-100-1980-0; Five thousand dollars and no cents (\$5,000.00) of FY18 Bonus Distribution Funds for Administrative costs 4550-100-1980-0 for February and March 2018 Tribal Per Capita Distributions under **Bonus Distribution** which also amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Sixty-eight million four hundred twenty-nine thousand five hundred thirty-two dollars and sixty-three cents (\$68,429,532.63).
