

Ordinance 40-18

An ordinance of Supplemental Appropriation for October and November 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2019.

The District II Representative introduced the following Bill on the 20<sup>th</sup> day of September, 2019.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for October and November 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2019.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for October and November 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2019.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million five hundred sixty-two thousand five hundred forty-six dollars and no cents (\$5,562,546.00) of FY19 Bonus Distribution Funds for Adult Distributions 6668-100-1980-0; Five thousand dollars and no cents (\$5,000.00) of FY19 Bonus Distribution Funds for Administrative costs 4550-100-1980-0 for October and November 2018 Tribal Per Capita Distributions under **Bonus Distribution** which also amends the **Total Fiscal Year 2019 Mille Lacs Band Tribal Operations** to read: Five million six hundred twenty-eight thousand forty-six dollars and no cents (\$5,628,046.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:





A Bill of Supplemental Appropriation for October and November 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2019.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for October and November 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2019.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for October and November 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2019.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million five hundred sixty-two thousand five hundred forty-six dollars and no cents (\$5,562,546.00) of FY19 Bonus Distribution Funds for Adult Distributions 6668-100-1980-0; Five thousand dollars and no cents (\$5,000.00) of FY19 Bonus Distribution Funds for Administrative costs 4550-100-1980-0 for October and November 2018 Tribal Per Capita Distributions under **Bonus Distribution** which also amends the **Total Fiscal Year 2019 Mille Lacs Band Tribal Operations** to read: Five million six hundred twenty-eight thousand forty-six dollars and no cents (\$5,628,046.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
