

Ordinance 34-18

An Ordinance of Supplemental Appropriation for August and September 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

The District II Representative introduced the following Bill on the 24<sup>th</sup> day of July, 2018.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for August and September 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for August and September 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six million three hundred seven thousand eighty dollars and no cents (\$6,307,080.00) of FY18 Bonus Distribution Funds for Adult Distributions 6668-100-1980-0; Four million two hundred ninety-five thousand two hundred dollars and no cents (\$4,295,200.00) of FY18 Bonus Distribution Funds for Minor Distributions 668-100-1980-0 Five thousand dollars and no cents (\$5,000.00) of FY18 Bonus Distribution Funds for Administrative costs 4550-100-1980-0 for June and July 2018 Tribal Per Capita Distributions under **Bonus Distribution** which also amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Two hundred seventy-one million six hundred sixty-five thousand six hundred seventy-five dollars and one cent (\$271,665,675.01).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for August and September 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six million three hundred seven thousand eighty dollars and no cents (\$6,307,080.00) of FY18 Bonus Distribution Funds for Adult Distributions 6668-100-1980-0; Four million two hundred ninety-five thousand two hundred dollars and no cents (\$4,295,200.00) of FY18 Bonus Distribution Funds for Minor Distributions 668-100-1980-0 Five thousand dollars and no cents (\$5,000.00) of FY18 Bonus Distribution Funds for Administrative costs 4550-100-1980-0 for June and July 2018 Tribal Per Capita Distributions under **Bonus Distribution** which also amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Two hundred seventy-one million six hundred sixty-five thousand six hundred seventy-five dollars and one cent (\$271,665,675.01).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:




