

Ordinance 42-18

An Ordinance of Supplemental Appropriation for Supplemental Economic Expenditure for Fiscal Year ending September 30, 2018.

The District II Representative introduced the following Bill on the 25th day of September, 2018.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Supplemental Economic Expenditure for Fiscal Year ending September 30, 2018.

Title I

Section 1: Supplemental Economic Expenditure. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for Supplemental Economic Expenditure for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million four hundred fifty-one thousand five hundred eighty-five dollars and no cents (\$5,451,585.00) of FY18 Long Term Savings Funds for Supplemental Economic Expenditure 6668-100-1970-0 to cover the projected excess for the FY18 Per Capita Bonus Distributions under **Supplemental Economic Expenditure** which also amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Two hundred eighty-four million one hundred eighty thousand one hundred eighty-five dollars and sixty-six cents (\$284,180,185.66).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:





A Bill of Supplemental Appropriation for Supplemental Economic Expenditure for Fiscal Year ending September 30, 2018.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Supplemental Economic Expenditure for Fiscal Year ending September 30, 2018.

Title I

Section 1: Supplemental Economic Expenditure. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for Supplemental Economic Expenditure for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million four hundred fifty-one thousand five hundred eighty-five dollars and no cents (\$5,451,585.00) of FY18 Long Term Savings Funds for Supplemental Economic Expenditure 6668-100-1970-0 to cover the projected excess for the FY18 Per Capita Bonus Distributions under **Supplemental Economic Expenditure** which also amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Two hundred eighty-four million one hundred eighty thousand one hundred eighty-five dollars and sixty-six cents (\$284,180,185.66).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
