

Ordinance 18-18

An Ordinance of Supplemental Appropriation for April and May 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

The District I Representative introduced the following Bill on the 29th day of March, 2018.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for April and May 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for April and May 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million nine hundred fifty-two thousand five hundred forty dollars and no cents (\$5,952,540.00) of FY18 Bonus Distribution Funds for Adult Distributions 6668-100-1980-0; Four million three hundred thirty-one thousand six hundred dollars and no cents (\$4,331,600.00) of FY18 Bonus Distribution Funds for Minor Distributions 6668-100-1980-0; Five thousand dollars and no cents (\$5,000.00) of FY18 Bonus Distribution Funds for Administrative costs 4550-100-1980-0 for April and May 2018 Tribal Per Capita Distributions under **Bonus Distribution** which also amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: One hundred one million three hundred eighty-nine thousand one hundred sixty-seven dollars and twenty-four cents (\$101,389,167.24).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:





Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for April and May 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for April and May 2018 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million nine hundred fifty-two thousand five hundred forty dollars and no cents (\$5,952,540.00) of FY18 Bonus Distribution Funds for Adult Distributions 6668-100-1980-0; Four million three hundred thirty-one thousand six hundred dollars and no cents (\$4,331,600.00) of FY18 Bonus Distribution Funds for Minor Distributions 6668-100-1980-0; Five thousand dollars and no cents (\$5,000.00) of FY18 Bonus Distribution Funds for Administrative costs 4550-100-1980-0 for April and May 2018 Tribal Per Capita Distributions under **Bonus Distribution** which also amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: One hundred one million three hundred eighty-nine thousand one hundred sixty-seven dollars and twenty-four cents (\$101,389,167.24).
