#### Ordinance 36-18

An Ordinance of Supplemental Appropriation for Adult Band Member Supplemental Economic Payments from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2018.

The District II Representative introduced the following Bill on the 7<sup>th</sup> day of August, 2018.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2018.

### Title I

Section 1: Non-Gaming Revenue: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: One million nine hundred thousand dollars and no cents (\$1,900,000.00) of FY18 Taxation Revenue Funds Adult Band Members at \$1,000 each (18 years and older, effective August 17, 2018); One million three hundred eighty-two thousand dollars and no cents (\$1,382,000.00) of FY18 Unspent/Net Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective August 17, 2018); Five thousand dollars and no cents (\$5,000.00) of FY18 Unspent/Net Revenue Funds for Administration Costs for Supplemental Economic Payments which amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Two hundred seventy-six million fifteen thousand seven hundred fifty-two dollars and sixty-five cents (\$276,015,752.65).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
