

Ordinance 17-18

An Ordinance of Supplemental Appropriation for The Chief Executive Department for Fiscal Year ending September 30, 2018.

The District II Representative introduced the following Bill on the 22nd day of March, 2018.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for The Chief Executive Department for the fiscal year ending September 30, 2018.

Title I.

Section 1: Unspent/Net Revenue. The Band Assembly hereby appropriates and authorizes an expenditure for The Chief Executive Department for fiscal year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: Four hundred eighty-two thousand eight hundred ninety-nine dollars and sixty cents (\$482,899.60) for Chief Executive 100-200-5700 of FY18 Unspent/Net Revenue Funds to purchase two turf level stadium suites at the U.S. Bank Stadium for the 2018 season under **Chief Executive** which amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Ninety-one million one hundred thousand twenty-seven dollars and twenty-four cents (\$91,100,027.24).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:


