

Ordinance 11-18

An Ordinance of Supplemental Appropriation for the Chief Executive Department for the Fiscal Year ending September 30, 2018.

The District II Representative introduced the following Bill on the 9<sup>th</sup> day of January, 2018.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for The Chief Executive Department for the fiscal year ending September 30, 2018.

Title I.

Section 1: Unspent/Net Revenue. The Band Assembly hereby appropriates and authorizes an expenditure for The Chief Executive Department for fiscal year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: One hundred thirty-six thousand five hundred dollars and no cents (\$136,500.00) for Chief Executive 100-200-5700 of FY18 Unspent/Net Revenue Funds to purchase two turf level stadium suites at the U.S. Bank Stadium for the 2017-2018 Playoff Season under **Chief Executive** which amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Thirty million one hundred thousand one hundred ninety-eight dollars and twelve cents (\$30,100,198.12).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Title I.
