

Ordinance 36-18

An Ordinance of Supplemental Appropriation for Adult Band Member Supplemental Economic Payments from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2018.

The District II Representative introduced the following Bill on the 7th day of August, 2018.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2018.

Title I

Section 1: Non-Gaming Revenue: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of : One million nine hundred thousand dollars and no cents (\$1,900,000.00) of FY18 Taxation Revenue Funds Adult Band Members at \$1,000 each (18 years and older, effective August 17, 2018); One million three hundred eighty-two thousand dollars and no cents (\$1,382,000.00) of FY18 Unspent/Net Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective August 17, 2018); Five thousand dollars and no cents (\$5,000.00) of FY18 Unspent/Net Revenue Funds for Administration Costs for Supplemental Economic Payments which amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Two hundred seventy-six million fifteen thousand seven hundred fifty-two dollars and sixty-five cents (\$276,015,752.65).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:



Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2018.

Title I

Section 1: Non-Gaming Revenue: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2018.

The Band Assembly hereby appropriates and authorizes the expenditure of : One million nine hundred thousand dollars and no cents (\$1,900,000.00) of FY18 Taxation Revenue Funds Adult Band Members at \$1,000 each (18 years and older, effective August 17, 2018); One million three hundred eighty-two thousand dollars and no cents (\$1,382,000.00) of FY18 Unspent/Net Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective August 17, 2018); Five thousand dollars and no cents (\$5,000.00) of FY18 Unspent/Net Revenue Funds for Administration Costs for Supplemental Economic Payments which amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Two hundred seventy-six million fifteen thousand seven hundred fifty-two dollars and sixty-five cents (\$276,015,752.65).
