

Ordinance 26-18

A Bill of Supplemental Appropriation for the Department of Justice for the Fiscal Year ending September 30, 2018.

The District III Representative introduced the following Bill on the 21st day of June, 2018.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditure for the Department of Justice for the Fiscal Year ending September 30, 2018.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditure for the Department of Justice for the Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two hundred thousand dollars and no cents (\$200,000.00) for Legal Services 5100-100-2150-0 of FY18 Unspent/Net Revenue Funds to cover the costs associated with Lockridge Grindal Nauen P.L.L.P. Legal Services contract under **Department of Justice** which amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Two hundred thirty-two million eight hundred ninety-one thousand nine hundred thirty-four dollars and seventy-five cents (\$232,891,934.75).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:



The OSG recently made two separate requests for appropriation and one request for a transfer of funds from Law Enforcement in efforts to reconcile its Legal Services line item.
