

Ordinance 28-18

An Ordinance of Supplemental Appropriation for the Legislative Department for the Fiscal Year ending September 30, 2018.

The District II Representative introduced the following Bill on the 28<sup>th</sup> day of June, 2018.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditure for the Legislative Department for the Fiscal Year ending September 30, 2018.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditure for the Legislative Department for the Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: One hundred sixty thousand dollars and no cents (\$160,000.00) for OMB Burial Insurance 6125-101-2100-5 of FY18 Unspent/Net Revenue Funds to cover the costs associated with burial insurance funds through the FY17-FY18 budget; Twenty-five thousand dollars and no cents (\$15,000.00) for OMB Consulting Contracting 4300-101-2100-5 of FY18 Unspent/Net Revenue Funds to cover any unexpected consulting time that Eide Bailly may bill the Band for additional consulting support on the Department of Labor forensic audit under **Legislative** which amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Two hundred thirty-three million sixty-six thousand nine hundred thirty-four dollars and seventy-five cents (\$233,066,934.75).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:


