### Ordinance 31-18

An Ordinance of Supplemental Appropriation for the Legislative Department for the Fiscal Year ending September 30, 2018.

The District II Representative introduced the following Bill on the 19<sup>th</sup> day of July, 2018.

#### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing an expenditure for the Legislative Department for the Fiscal Year ending September 30, 2018.

### Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes an expenditure for the Legislative Department for the Fiscal Year ending September 30, 2018.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes an expenditure of: Three hundred forty-six thousand dollars and no cents (\$346,000.00) as the second and final portion of the 2017-2018 Band donation from the Mille Lacs Band to the Minisinaakwaang Leadership Academy 6668-206-3060-0 of FY18 Unspent/Net Revenue Funds to provide Ojibwe Culture & Language activities, academic infrastructure, and technology services to its students under **Legislative** which amends the **Total Fiscal Year 2018 Mille Lacs Band Tribal Operations** to read: Two hundred fifty-seven million four hundred fifty thousand three hundred forty dollars and one cent (\$257,450,340.01).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:
