

Ordinance 32-19

An Ordinance of Appropriation for the Housing Initiative program of the Mille Lacs Band Tribal Government for Fiscal Year ending September 30, 2019.

The District I Representative introduced the following Bill on this 21st day of May, 2019.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating funds for the Housing Initiative program for Fiscal Year ending September 30, 2019.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates funds for the Housing Initiative program.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: Six million, one hundred sixty-three thousand, eight hundred twenty-one dollars and sixty-five cents (\$6,163,821.65) for Housing Initiative 108-2350-0 of a Re-Appropriation of FY18 Housing Initiative Funds to continue ongoing projects as submitted; Four million, five hundred forty thousand, seven hundred three dollars and thirty-four cents (\$4,540,703.34) for Housing Initiative 108-2350-0 of FY19 Housing Initiative Funds in new funding as submitted under **Community Development** which amends the **Total Fiscal Year 2019 Mille Lacs Band Housing Initiative** to read: Nineteen million, five hundred fifty-three thousand, one hundred fifty-one dollars and forty-two cents (\$19,553,151.42); and

Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of programmatic funds and specifically allocates these funds for the following Housing Initiative functions as detailed below:

Section 2. No expenditure that causes an appropriation to be exceeded may be paid under any circumstance without further Band Assembly action.

Section 3. Indirect costs shall be collected from the particular programs based on the current rate approved by the United States Department of Interior and/or Office of Inspector General unless limited to a lesser rate by applicable federal or state regulations.

Section 4. The Band Assembly and Chief Executive agree that quarterly progress reports shall be submitted to the Band Assembly by all Commissioners for their respective programs. The Band Assembly shall notify the office of the Chief Executive and the office of each Commissioner scheduled to appear at least three (3) calendar days prior to their scheduled appearance.

Section 5. Except as otherwise exempted, all appropriations shall lapse at the end of each Fiscal Year and may be available for re-appropriation by the Band Assembly.

Section 6. The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 (Ten thousand dollars and no cents) per line item. All line item 7200 series must be approved by Band Assembly.

Section 7. All funds appropriated for capital construction projects shall be appropriated to align with the project length and shall not automatically carry over to the next Fiscal Year. If appropriated funds remain, and if the project is not completed within the Fiscal Year 2019, capital construction projects shall be re-appropriated. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, the Band Assembly must be notified immediately.


