Ordinance 51-19

An Ordinance of Supplemental Appropriation for October and November 2019 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

The District I Representative introduced the following Bill on the 17th day of October, 2019.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for October and November 2019 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for October and November 2019 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million, seven hundred eight thousand, ninety-four dollars and no cents (\$5,708,094.00) for Adult Distributions 6668-100-1980-0 of FY20 Bonus Distribution Funds to cover the October and November 2019 Tribal Per Capita Distributions; Five thousand dollars and no cents (\$5,000.00) for Administrative costs 4550-100-1980-0 of FY20 Bonus Distribution Funds to cover the cost to process the October and November 2019 Tribal Per Capita Distributions under **Bonus Distribution** which also amends the **Total Fiscal Year 2020 Mille Lacs Band Tribal Operations** to read: Six million, two hundred eighty-one thousand, one hundred eighty-seven dollars and no cents (\$6,281,187.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
