### Ordinance 20-19

An Ordinance of Supplemental Appropriation and Budget Revision/Transfers for the Education and Health & Human Services Departments for the Fiscal Year September 30, 2019.

The District I Representative introduced the following Bill on the 28th day of February, 2019.

# Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures and budget revision/transfers for the Education and Health & Human Services Departments for the Fiscal Year September 30, 2019.

#### Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures and budget revision/transfers for the Education and Health & Human Services Departments for the Fiscal Year September 30, 2019.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Thirty thousand, two hundred fifty-nine dollars and sixty-one cents (\$30,259.61) for ALU O&M 221-4370-0 of a Re-Appropriation of FY18 Self-Governance Funds as submitted; Three hundred forty-six thousand, seven hundred sixty-four dollars and no cents (\$346,764.00) for Elder Energy of FY19 Unspent/Net Revenue Funds to support the Elder Energy program as submitted under **Health & Human Services**; Three thousand, two hundred seventy-five dollars and no cents (\$3,275.00) for CSBG 203-3330-2 of FY19 Grant Funds as submitted; Eight thousand, seven hundred seventy dollars and no cents (\$8,770.00) for STRIVE Literacy 202-3540-2 of FY19 Grant Funds as submitted under **Education** which amends the **Total Fiscal Year 2019 Mille Lacs Band Tribal Operations** to read: One hundred ninety-nine million, two hundred sixty-two thousand, six hundred fifty-nine dollars and thirty-six cents (\$199,262,659.36).

Program Activities 6800-203-3330-2 \$25,000.00 Total \$25,000.00 Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2019. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

Section 1.05: The Band Assembly hereby authorizes Commissioners to approve budgetary revisions within programs <u>up</u> to \$10,000.00 provided that the revisions are allowable under grant provisions, if applicable and that sufficient funds are available for the revision. For revisions <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget revisions within programs of <u>up</u> to 50% of the total program's budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

Section 1.06: All funds appropriated are maximum fund amounts and shall not be exceeded.
