The Band Assembly hereby appropriates and authorizes an expenditure of: Two hundred forty-six thousand dollars and no cents (\$246,000.00) as the remaining payment of the first half Band donation to the Minisinaakwaang Leadership Academy 6668-206-3060-0 of FY19 Unspent/Net Revenue Funds to provide Ojibwe Culture & Language activities, academic infrastructure, and technology services to its students under **Legislative** which amends the **Total Fiscal Year 2019 Mille Lacs Band Tribal Operations** to read: One hundred eighty-five million, seventy thousand, sixty dollars and thirty cents (\$185,070,060.30).
