

## Ordinance 13-19

An Ordinance of Supplemental Appropriation for the Legislative Branch for the Fiscal Year ending September 30, 2019.

The District I Representative introduced the following Bill on the 26<sup>th</sup> day of December, 2018.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Legislative Branch for the Fiscal Year ending September 30, 2019.

### Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Legislative Branch for the Fiscal Year ending September 30, 2019.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two hundred nineteen thousand, two hundred seventy-five dollars and forty cents (\$219,275.40) for OMB Miscellaneous 5700-101-2100-5 of FY19 Unspent/Net Revenue Funds to provide a year-end bonus to Mille Lacs Band Employees as submitted under **Legislative Branch** which amends the **Total Fiscal Year 2019 Mille Lacs Band Tribal Operations** to read: One hundred forty-seven million, eight hundred forty thousand, five hundred ninety-six dollars and five cents (\$147,840,596.05).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:



A Bill of Supplemental Appropriation for the Legislative Branch for the Fiscal Year ending September 30, 2019.

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Legislative Branch for the Fiscal Year ending September 30, 2019.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Legislative Branch for the Fiscal Year ending September 30, 2019.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two hundred nineteen thousand, two hundred seventy-five dollars and forty cents (\$219,275.40) for OMB Miscellaneous 5700-101-2100-5 of FY19 Unspent/Net Revenue Funds to provide a year-end bonus to Mille Lacs Band Employees as submitted under **Legislative Branch** which amends the **Total Fiscal Year 2019 Mille Lacs Band Tribal Operations** to read: One hundred forty-seven million, eight hundred forty thousand, five hundred ninety-six dollars and five cents (\$147,840,596.05).
