Ordinance 48-19

An Ordinance of Supplemental Appropriation and Budget Revision/Transfers for the Natural Resources, Health & Human Services, Justice, Education, and Community Development Departments for the Fiscal Year ending September 30, 2019.

The District I Representative introduced the following Bill on the 3rd day of October, 2019.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures and budget revision/transfers for the Natural Resources, Health & Human Services, Justice, Education, and Community Development Departments for the Fiscal Year ending September 30, 2019.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures and budget revision/transfers for the Natural Resources, Health & Human Services, Justice, Education, and Community Development Departments for the Fiscal Year ending September 30, 2019.

If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

Section 1.05: All funds appropriated are maximum fund amounts and shall not be exceeded.
