

Ordinance 42-19

An Ordinance of Supplemental Appropriation for Adult Band Member Supplemental Economic Payments from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2019.

The District III Representative introduced the following Bill on the 25th day of July, 2019.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2019.

Title I

Section 1: Non-Gaming Revenue: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2019.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of : Two million, nineteen thousand dollars and no cents (\$2,019,000.00) of FY19 Taxation Revenue Funds Adult Band Members at \$1,000 each (18 years and older, effective August 15, 2019); One million, three thousand dollars and no cents (\$1,300,000.00) of FY19 Unspent/Net Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective August 15, 2019); Five thousand dollars and no cents (\$5,000.00) of FY19 Unspent/Net Revenue Funds for Administration Costs for Supplemental Economic Payments which amends the **Total Fiscal Year 2019 Mille Lacs Band Tribal Operations** to read: Two hundred fifty million, five hundred ninety-five thousand, one hundred seven dollars and thirty-six cents (\$250,953,665.02).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:



A Bill of Supplemental Appropriation for Adult Band Member Supplemental Economic Payments from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2019.

The District III Representative introduced the following Bill on the 25th day of July, 2019.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2019.

Title I

Section 1: Non-Gaming Revenue: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments from the Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2019.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of : Two million, nineteen thousand dollars and no cents (\$2,019,000.00) of FY19 Taxation Revenue Funds Adult Band Members at \$1,000 each (18 years and older, effective August 15, 2019); One million, three thousand dollars and no cents (\$1,300,000.00) of FY19 Unspent/Net Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective August 15, 2019); Five thousand dollars and no cents (\$5,000.00) of FY19 Unspent/Net Revenue Funds for Administration Costs for Supplemental Economic Payments which amends the **Total Fiscal Year 2019 Mille Lacs Band Tribal Operations** to read: Two hundred fifty million, five hundred ninety-five thousand, one hundred seven dollars and thirty-six cents (\$250,953,665.02).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
