## Ordinance 23-20

An Ordinance of Supplemental Appropriation for February and March 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

The District III Representative introduced the following Bill on the 28th day of January, 2020.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for February and March 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

## Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for February and March 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million, eight hundred ninety-six thousand, five hundred sixty dollars and no cents (\$5,896,560.00) for Adult Distributions 6668-100-1980-0 of FY20 Bonus Distribution Funds to cover the February and March 2020 Tribal Per Capita Distributions; Five thousand dollars and no cents (\$5,000.00) for Administrative costs 4550-100-1980-0 of FY20 Bonus Distribution Funds to cover the cost to process the February and March 2020 Tribal Per Capita Distributions under **Bonus Distribution** which also amends the **Total Fiscal Year 2020 Mille Lacs Band Tribal Operations** to read: Forty-one million, three hundred sixty-five thousand, seven hundred thirty-seven dollars and fifty-eight cents (\$41,365,737.58).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
