### Ordinance 08-20

An Ordinance of Supplemental Appropriation and Budget Revision/Transfers for the Education, Justice, Natural Resources, Health & Human Services, Administration, and Judicial Departments for the Fiscal Years ending September 30, 2019 and September 30, 2020.

The District I Representative introduced the following Bill on the 7th day of November, 2019.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures and budget revision/transfers for the Education, Justice, Natural Resources, Health & Human Services, Administration, and Judicial Departments for the Fiscal Years ending September 30, 2019 and September 30, 2020.

#### Title I

Section 1: Governmental Operations.
