

Ordinance 12-20

An Ordinance of Supplemental Appropriation for Adult Band Member Supplemental Economic Payments from Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2020.

The District II Representative introduced the following Bill on the 19th day of November, 2019.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2020.

Title I

Section 1: Non-Gaming Revenue: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments from Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2020.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of : Two hundred ninety-one thousand dollars and no cents (\$291,633.00) of FY20 Taxation Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective December 5, 2019); Three million, forty-five thousand, three hundred and sixty-seven dollars and no cents (\$3,045,367.00) of FY20 Unspent/Net Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective December 5, 2019); Five thousand dollars and no cents (\$5,000.00) of FY20 Unspent/Net Revenue Funds for Administration Costs for Supplemental Economic Payments which amends the **Total Fiscal Year 2020 Mille Lacs Band Tribal Operations** to read: Thirteen million, four hundred sixty-two thousand, one hundred ninety-eight dollars and six cents (\$13,462,198.06).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:



A Bill of Supplemental Appropriation for Adult Band Member Supplemental Economic Payments from Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2020.

The District II Representative introduced the following Bill on the 19th day of November, 2019.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2020.

Title I

Section 1: Non-Gaming Revenue: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments from Taxation and Unspent/Net Revenue Funds for Fiscal Year ending September 30, 2020.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of : Two hundred ninety-one thousand dollars and no cents (\$291,633.00) of FY20 Taxation Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective December 5, 2019); Three million, forty-five thousand, three hundred and sixty-seven dollars and no cents (\$3,045,367.00) of FY20 Unspent/Net Revenue Funds for Adult Band Members at \$1,000 each (18 years and older, effective December 5, 2019); Five thousand dollars and no cents (\$5,000.00) of FY20 Unspent/Net Revenue Funds for Administration Costs for Supplemental Economic Payments which amends the **Total Fiscal Year 2020 Mille Lacs Band Tribal Operations** to read: Thirteen million, four hundred sixty-two thousand, one hundred ninety-eight dollars and six cents (\$13,462,198.06).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
