

## Ordinance 51-20

An Ordinance repealing Band Assembly Bill 18-03-16-19, enacted as Band Ordinance 16-19, and amending Chapter 13 of Title 8 entitled “Child Protection” of the Mille Lacs Band Statutes Annotated (“MLBSA”) (Band Assembly Bill 17-03-31-17, enacted as Band Ordinance 31-17), for the purposes of amending the effective date to Chapter 13 and to clarify the applicability of Chapter 13 to court cases opened prior to December 1, 2020.

The District 1 Representative introduced the following Bill on the 29<sup>th</sup> day of July, 2020.

### Preamble

It is enacted, by the Band Assembly of the Mille Lacs Band of Ojibwe, for the purposes of repealing Band Assembly Bill 18-03-16-19, enacted as Band Ordinance 16-19, amending Chapter 13 of Title 8 entitled “Child Protection” of the Mille Lacs Band Statutes Annotated, for the purposes of adding an effective date to Chapter 13, and to clarify the applicability of Chapter 13 to court cases opened prior to December 1, 2020. Chapter 13 shall be amended to include Section 3002.

### Title 8 Chapter 13

#### **Section 1:**

#### **§ 3002. EFFECTIVE DATE**


- (a) The effective date of Chapter 13, as amended by Ordinance 33-18 and 16-19, shall be December 1, 2020.
- (b) Chapter 13, as amended by Ordinance 31-17, 33-18, and 16-19, shall not be retroactive or attach new legal consequences to events, orders or decisions preceding the effective date of the statute.
- (c) Any motion or procedure that is pending in an open case before the Court of Central Jurisdiction or Court of Appeals on or after the effective date of December 1, 2020 shall be decided based on the law in effect prior to December 1, 2020.



Chapter 13 shall be amended to include Section 3002.

### Title 8 Chapter 13

#### **Section 1:**

#### **§ 3002. EFFECTIVE DATE**

- (a) The effective date of Chapter 13, as amended by Ordinance 33-18 and 16-19, shall be December 1, 2020.
- (b) Chapter 13, as amended by Ordinance 31-17, 33-18, and 16-19, shall not be retroactive or attach new legal consequences to events, orders or decisions preceding the effective date of the statute.
- (c) Any motion or procedure that is pending in an open case before the Court of Central Jurisdiction or Court of Appeals on or after the effective date of December 1, 2020 shall be decided based on the law in effect prior to December 1, 2020.
