

Ordinance 09-20

An Ordinance amending 7 MLBSA § 10 (b) to amend the procurement price requirement for small purchase procedures and 7 MLBSA § 16 (a) to amend the procurement price requirement for procurement record keeping.

The District II Representative introduced the following Bill on the 17th day of October, 2019.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe, for the purpose of amending 7 MLBSA § 10 (b) to amend the procurement price requirement for small purchase procedures and 7 MLBSA § 16 (a) to amend the procurement price requirement for procurement record keeping.

The Band Assembly amends 7 MLBSA § 10 (b) and 7 MLBSA § 16 (a) by changing the following language:

7 MLBSA § 10 (b) currently states:

Competition will be obtained whenever the price of an item is estimated to exceed \$2000. Price or rate quotations shall be obtained from at least three (3) qualified sources if available.

7 MLBSA § 10 (b) shall be amended to state:

Competition will be obtained whenever the price of an item is estimated to exceed \$5000. Price or rate quotations shall be obtained from at least three (3) qualified sources if available.

7 MLBSA § 16 (a) currently states:

The Mille Lacs Band will maintain records in sufficient detail to track the significant history of all procurements over \$2000. The records shall include, but are not limited to information pertinent to the following: rationale for the method of procurement, selection of contract type, contractor selection or rejection and the basis for the price.

7 MLBSA § 16 (a) shall be amended to state:


The Mille Lacs Band will maintain records in sufficient detail to track the significant history of all procurements over \$5000. The records shall include, but are not limited to information pertinent to the following: rationale for the method of procurement, selection of contract type, contractor selection or rejection and the basis for the price.

After the passage of this legislation by the Band Assembly in accordance with 3 MLBSA § 16 (b) and by approval or non-action by the Chief Executive in accordance with 4 MLBSA § 16(c), this amendment shall become effective on November 22, 2019.


