

Ordinance 36-20

An Ordinance of Supplemental Appropriation for Adult Band Member Economic Stimulus Payments from Long-Term Savings Funds for the month of May 2020 in the Fiscal Year ending September 30, 2020.

The District III Representative introduced the following Bill on the 22nd day of April, 2020.

Preamble

Following the passage of Ordinance 33-20 (Supplemental Appropriation for Adult Band Member Economic Stimulus Payments), it was discovered that fifty-eight (58) eighteen (18) year old Adult Band Members were not included in the count, in error. The report is in date order with youngest listed last, and the count total had stopped at May 1, 2001, and should have gone to May 1, 2002. Also, six (6) adult Band Members have passed away since the report was last run, resulting in a net increase to the previously approved total of fifty-two (52). Fifty-two (52) times one thousand five hundred dollars and no cents (\$1,500.00) equals a total of Seventy-eight thousand dollars and no cents (\$78,000.00).

Title I

Section 1: Long-Term Savings Funds: Adult Band Member Supplemental Economic Stimulus Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Supplemental Economic Stimulus Payments from Long-Term Savings Funds for the month of May 2020 of the Fiscal Year ending September 30, 2020.

Section 1.01: The Band Assembly hereby appropriates and authorizes the expenditure of: Seventy-eight thousand dollars and no cents (\$78,000.00) of Long-Term Savings Funds for Adult Band Members. The Adult Band member payment is set at One thousand five hundred dollars and no cents (\$1,500.00) each (18 years and older, on May 1, 2020); a maximum of: Four hundred sixty-six dollars and fifty cents (\$466.50) may be intercepted for Child Support purposes, and Child Support notice requirements are waived for this Economic Stimulus payment, which amends the **Total Fiscal Year 2020 Mille Lacs Band Tribal Operations** to read: Two hundred million, thirty-one thousand, four hundred twenty-eight dollars and forty-eight cents (\$200,031,428.48).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:



Section 1.01: The Band Assembly hereby appropriates and authorizes the expenditure of: Seventy-eight thousand dollars and no cents (\$78,000.00) of Long-Term Savings Funds for Adult Band Members. The Adult Band member payment is set at One thousand five hundred dollars and no cents (\$1,500.00) each (18 years and older, on May 1, 2020); a maximum of: Four hundred sixty-six dollars and fifty cents (\$466.50) may be intercepted for Child Support purposes, and Child Support notice requirements are waived for this Economic Stimulus payment, which amends the **Total Fiscal Year 2020 Mille Lacs Band Tribal Operations** to read: Two hundred million, thirty-one thousand, four hundred twenty-eight dollars and forty-eight cents (\$200,031,428.48).
