

Ordinance 28-20

An Ordinance of Supplemental Appropriation for April and May 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

The District II Representative introduced the following Bill on the 19th day of March, 2020.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for April and May 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for April and May 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six million, one hundred forty-seven thousand, five hundred thirty-seven dollars and no cents (\$6,147,537.00) for Adult Distributions 6668-100-1980-0 of FY2020 Bonus Distribution Funds to cover the April and May 2020 Tribal Per Capita Distributions; Four million, five hundred twenty-two thousand dollars and no cents (\$4,522,000.00) for Minor Distribution 6668-100-1980-0 of FY2020 Bonus Distribution Funds to cover the April and May 2020 Tribal Per Capita Distributions; Five thousand dollars and no cents (\$5,000.00) for Administrative costs 4550-100-1980-0 of FY2020 Bonus Distribution Funds to cover the cost to process the April and May 2020 Tribal Per Capita Distributions under **Bonus Distribution** which also amends the **Total Fiscal Year 2020 Mille Lacs Band Tribal Operations** to read: Eighty-five million, sixty-seven thousand, four hundred twenty-four dollars and ninety-four cents (\$85,067,424.94).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:




