Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Education, Natural Resources, Community Development, and Health & Human Services Departments for the Fiscal Year ending September 30, 2020.

Title I

Section 1.04: All funds appropriated are maximum fund amounts and shall not be exceeded.
