

Ordinance 52-20

An Ordinance of Supplemental Appropriations for the Education and Health & Human Services Departments for the Fiscal Year ending September 30, 2020.

The District III Representative introduced the following Bill on the 5th day of August, 2020.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Education and Health & Human Services Departments for the Fiscal Year ending September 30, 2020.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Education and Health & Human Services Departments for the Fiscal Year ending September 30, 2020.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: One hundred forty-seven thousand, nine hundred dollars and no cents (\$147,900.00) for CARES Act 203-NEW-4 of FY2020 Miscellaneous Revenue Funds to support school reopen/PPE and technology needs for NASS including response to the COVID-19 pandemic as submitted of under **Education**; One hundred thousand dollars and no cents (\$100,000.00) for Food/Transportation 223-NEW of FY2020 Grant Funds from MN DHS American Indian Food Security Grant through Hunger Solutions funding to support the MLBO food shelf as submitted under **Health & Human Services** which amends the **Total Fiscal Year 2020 Mille Lacs Band Tribal Operations** to read: Two hundred twenty-five million, six hundred forty-two thousand, one hundred twelve dollars and sixty-eight cents (\$225,642,112.68).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:

Section 1.03: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2020. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

Section 1.04: All funds appropriated are maximum fund amounts and shall not be exceeded.


