Ordinance 13-20

An Ordinance of Supplemental Appropriation for December 2019 and January 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

The District III Representative introduced the following Bill on the 21st day of November, 2019.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for December 2019 and January 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for December 2019 and January 2020 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2020.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six million, three hundred eighty-six thousand, three hundred eighty-five dollars and no cents (\$6,386,385.00) for Adult Distributions 6668-100-1980-0 of FY20 Bonus Distribution Funds to cover the December 2019 and January 2020 Tribal Per Capita Distributions; Four million, two hundred forty-seven thousand, six hundred dollars and no cents (\$4,247,600.00) for Minor Distributions 6668-100-1980-0 of FY20 Bonus Distribution Funds to cover the December 2019 and January 2020 Tribal Per Capita Distributions; Five thousand dollars and no cents (\$5,000.00) for Administrative costs 4550-100-1980-0 of FY20 Bonus Distribution Funds to cover the cost to process the December 2019 and January 2020 Tribal Per Capita Distributions under Bonus Distribution which also amends the Total Fiscal Year 2020 Mille Lacs Band Tribal Operations to read: Twenty-four million, one hundred one thousand, one hundred eighty-three dollars and six cents (\$24,101,183.06).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
