

Ordinance 40-20

An Ordinance of Supplemental Appropriations for the Legislative Department for the Fiscal Year ending September 30, 2020.

The District I Representative introduced the following Bill on the 13th day of May, 2020.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Legislative Department for the Fiscal Year ending September 30, 2020.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Legislative Department for the Fiscal Year ending September 30, 2020.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Ninety-nine thousand, five hundred twenty-four dollars and no cents (\$99,524.00) for D I Powwow 7200-101-1070-0 of FY2019 Carryover of Permanent Initiative Funds under **Legislative** which amends the **Total Fiscal Year 2020 Mille Lacs Band Tribal Operations** to read: Two hundred two million, five hundred thirty-eight thousand, two hundred seventy-five dollars and eighty cents (\$202,538,275.80).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:





Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Legislative Department for the Fiscal Year ending September 30, 2020.

Title I
