

Ordinance 20-21

An Ordinance of Supplemental Appropriation for Administration for the Fiscal Year Ending September 30, 2021.

The District III Representative introduced the following Bill on the 12<sup>th</sup> day of January, 2020.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for Administration for the Fiscal Year Ending September 30, 2021.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration for the Fiscal Year Ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Thirty-five thousand, three hundred dollars and no cents (\$35,300.00) for Elder Supplemental 107-2370-0 of FY2021 Elder Supplement Revenue Funds for Social Security Administration cost of living increase as submitted under **Administration** which amends the **Total Fiscal Year 2021 Mille Lacs Band Tribal Operations** to read: Sixty-one million, four hundred eighty-four thousand, nine hundred eighty-one dollars and twenty-four cents (\$61,484,981.24).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:
