

Ordinance 37-21

An Ordinance of Supplemental Appropriation for the June and July 2021 Tribal Per Capita Distributions for Adults for the Fiscal Year Ending September 30, 2021.

The District III Representative introduced the following Bill on the 28<sup>th</sup> day of April, 2021.

Preamble

It is enacted by the Band Assembly of the Non-Removable Mille Lacs Band of Ojibwe for the purpose of appropriating for the June and July 2021 Tribal Per Capita Distributions for Adults for the Fiscal Year Ending September 30, 2021.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for the June and July 2021 Tribal Per Capita Distributions for Adults for the Fiscal Year Ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Seven million, seven hundred twenty-eight thousand, seven hundred seven dollars and no cents (\$7,728,707.00) for Adult Distributions 6668-100-1980-0 of FY2021 Per Capita Distribution Funds to cover the June and July 2021 Tribal Per Capita Distributions under **Per Capita Distribution** which also amends the **Total Fiscal Year 2021 Mille Lacs Band Tribal Operations** to read: Two hundred forty million, three hundred fifty-five thousand, five hundred six dollars and ninety-seven cents (\$240,355,506.97).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Section 1.03: All funds appropriated are maximum fund amounts and shall not be exceeded. Funds must be utilized for the purposes identified herein.


