

Ordinance 30-21

An Ordinance of Supplemental Appropriation for January, February, March and April Tribal Per Capita Distributions for Minors and April and May 2021 Tribal Per Capita Distributions for Adults for the Fiscal Year Ending September 30, 2021.

The District I Representative introduced the following Bill on the 17<sup>th</sup> day of March, 2021.

Preamble

It is enacted by the Band Assembly of the Non-Removable Mille Lacs Band of Ojibwe for the purpose of appropriating for the January, February, March and April Tribal Per Capita Distributions for Minors and April and May 2021 Tribal Per Capita Distributions for Adults for the Fiscal Year Ending September 30, 2021.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for the purpose of appropriating for the January, February, March and April Tribal Per Capita Distributions for Minors and April and May 2021 Tribal Per Capita Distributions for Adults for the Fiscal Year Ending September 30, 2021.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million, eight hundred seventy-six thousand, three hundred sixty-five dollars and no cents (\$5,876,365.00) for Adult Distributions 6668-100-1980-0 of FY2021 Per Capita Distribution Funds to cover the April and May 2021 Tribal Per Capita Distributions; Four million, one hundred seventy thousand, six hundred dollars and no cents (\$4,170,600.00) for Minor Distribution 6668-100-1980-0 of FY2021 Per Capita Distribution Funds to cover the January, February, March, and April 2021 Tribal Per Capita Distributions under **Per Capita Distribution** which also amends the **Total Fiscal Year 2021 Mille Lacs Band Tribal Operations** to read: Two hundred twenty-one million, eight hundred seventy-five thousand, two hundred fifty-seven dollars and eleven cents (\$221,875,257.11).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:


